

PRIVACY POLICY

Kyoorius Communications Private Limited (Kyoorius) urges you to carefully read and review this Privacy Policy Statement before accessing or using this website “www.zeemelt.com” (hereinafter referred to as “Website”). If you proceed to access or use this Website, you are agreeing to abide by this Privacy Policy Statement, without any exceptions. You may not access or use this Website if you do not agree to this Privacy Policy Statement.

Kyoorius Communications Private Limited (Kyoorius), its subsidiaries, its affiliates and its group companies (hereinafter referred to as “Kyoorius”) reserve the right to add, remove or modify this information at any time without any prior notification.

Collection of Personally Identifiable Information

1. The Website is not designed to collect and/or receive any personally identifiable information by itself. Kyoorius is not able to identify you personally unless you access Website and/or provide any personally identifiable information.
2. Active collection of information: Kyoorius collects personal information that you enter into data fields on this Websites. For example, you may submit your name, postal address, email address, and/ or other information in order to receive information about various subjects. To protect your privacy, you should not provide Kyoorius with any information that is not specifically requested.
3. Passive Collection of information: Kyoorius’s Websites may collect information about your visits to the website without you actively submitting such information. This information may be collected using various technologies, such as cookies, Internet tags, and web beacons. The Website may capture some of this information, such as the URL of the website you just visited, Internet Protocol (IP) addresses, GPS location data, mobile phone service provider, details of operating system, the browser version your computer, etc. Passive information collection technologies can make your use of the Website easier by allowing Kyoorius to provide better service, customize sites based on consumer preferences, compile statistics, analyse trends, and otherwise administer and improve the Website. Such information collected by these technologies cannot be used to identify you without additional identifiable information.

Intended Use of Personally Identifiable Information

4. Kyoorius will use the personal information you provide through the Website to respond to your questions, have efficient communication and to provide you with efficient customer service. After you have entered personal information into a form or data field on the Website, Kyoorius may use certain identifying technologies to allow that website to “remember” your personal preferences, such as sections of the Website that you visit frequently and, if you choose, your user ID.
5. Kyoorius shall collect, store and use your information in compliance with all applicable laws. You may always limit the amount and type of personal information that Kyoorius receives about you by choosing not to enter any personal information into forms or data fields on the Website. Some of our online services can only be provided to you if you provide us with appropriate personal information. Other parts of the Website may ask whether you wish to opt out or opt into our contact lists for offers, promotions and additional services that may be of interest to you. Spamming

6. Kyoorius does not support "spamming". Spamming is defined as sending unsolicited emails, usually of a commercial nature, in large numbers and repeatedly to individuals with whom the sender has had no previous contact or who have declined to receive such communications. In contrast, Kyoorius may send periodic emails to its visitors on area of interest expressed by them, however giving you the choice of opting out of such service.

Non-Disclosure of Information

7. Personal information on the Website may be accessed by Kyoorius, by certain companies with which Kyoorius may conduct joint programs, and by individuals and entities with whom Kyoorius contracts to carry out business activities for Kyoorius.

8. Kyoorius does not sell or rent your personal Information with anyone else.

9. Kyoorius may share the personal information with third-party, if it is required for further processing or connection to its business. 10. We may release your personal information when we believe release is required to comply with applicable law. We may release personal information if, in our judgment after review, the release is compelled by law or regulation.

Protection of personal information

11. Kyoorius will maintain adequate technical and organizational security measures to protect personally identifiable information.

12. As a policy, Kyoorius secures each web page that collects personal information; however, the confidentiality of personal information transmitted over the Internet will not be guaranteed. We urge you to exercise caution when transmitting personal information over the Internet.

13. Kyoorius is not obliged to store your Information for a period which is beyond the intended purpose for which such Information was collected or submitted.

Links to other websites

14. This Privacy Policy applies only to Kyoorius 's websites. Kyoorius may provide links to other websites, which we believe, may be of interest to you. Kyoorius is not responsible for the content on such website, your access to such website links, security of personal information that you provide or any information collected by that website. Use of our websites by children

15. Kyoorius does not knowingly collect or use any personal information from children (we define "children" as minors younger than 18 (eighteen) on the Website). We do not knowingly allow children to communicate with us, or use any of our online services. If you are a parent and/or legal guardian and become aware that your child has provided us with information, please contact us and we will work with you to address this issue.

Right to access your personal information on the Website

16. 18. Miscellaneous Terms:

The Applicant hereby represents and warrants that:

- i) It is not under any exclusive contracts with any other third party/ agency or not under any kind of disqualification under any law to enter into an agreement with Kyoorius and/or to participate in the event.
- ii) Its Application(s) should not be obscene, vulgar, defaming, denigrating women or children, hurting religious sentiments, depicting violence or against the public policy of India and/or in violation of any of the applicable laws.
